

The Giver's Dozen Raffle

Official Rules

1. Promotional Overview:

The Giver's Dozen Raffle (the "Raffle"), sponsored by Trinity Foundation (the "Sponsor"), is a monthly raffle that serves as a long-term financial support initiative to help the Sponsor provide services and support for children and adults with developmental and mental disabilities.

2. Eligibility

The Raffle is open to legal residents of the United States who are 18 years of age. Directors, officers and employees of the Sponsor are not eligible to participate in the Raffle.

3. How to Enter

Participants may choose to enroll in the raffle on a semi-annual or annual basis by completing the Giver's Dozen Raffle Official Entry Form and returning it to the Sponsor. The Annual Raffle Participation Fee is \$60.00 and entitles participants to be entered into 12 monthly drawings. Raffle Participation Fees are non-refundable. Once the Sponsor has determined the eligibility of the participant, the participant will be enrolled in the next drawing.

4. Prize Winner Selection

An independent certified public accounting firm, currently McCarthy & McHugh, Ltd., will conduct and supervise the selection process. The drawings will take place at the independent certified public accounting firm's office in Joliet, Illinois. The Sponsor reserves the right to change the independent certified public accounting firm conducting the selection process without notice to participants. The winner selection process will take place on the last Friday of each month. To select a winner, each participant will be assigned a unique number, which will be entered into a computer program. The winning numbers will be randomly selected from the program using a formula designed to randomly select a unique number. Participants need not be present to win. Four entries will be selected at each monthly drawing. To arrange delivery/pick-up of the prize, the Sponsor will contact the prize winners at the contact number listed in the Giver's Dozen Raffle Official Entry Form. Prize winners must claim their prize within 30 days of notification by the Sponsor, otherwise such prize will be forfeited. In the event that any prize winner does not claim the prize or is determined to be ineligible to receive a prize, no other prize will be awarded or substituted. All decisions of the Sponsor will be final on all matters concerning the Raffle. These Official Rules shall not be changed by any oral statement made by any employee or other person acting on behalf of the Sponsor.

5. Prize

Four monthly prizes will be awarded in the following manner: the first winner selected will receive one \$150 cash prize; the second winner selected will receive one \$100 cash prize; and the third and fourth winners selected will each receive a \$75 cash prize. If there are fewer than 100 participants in any monthly drawing, each prize will be proportionately reduced based on the number of participants that month.

6. Odds of Winning

The odds of winning vary monthly, depending on the number of entries. For example, if there are 100 entries, each entry will have a 1 in 100 chance of being selected as the first winner, a 1 in 99 chance of being selected as the second winner, a 1 in 98 chance of being selected as the third winner and a 1 in 97 chance of being selected as the fourth winner.

7. Governing Law

ALL ISSUES AND QUESTIONS CONCERNING THE CONSTRUCTION, VALIDITY, INTERPRETATION AND ENFORCEABILITY OF THESE OFFICIAL RULES OR THE RIGHTS AND OBLIGATIONS OF PARTICIPANTS OR THE SPONSOR IN CONNECTION WITH THE RAFFLE SHALL BE GOVERNED BY THE LAWS OF THE STATE OF ILLINOIS WITHOUT GIVING EFFECT

TO ANY CHOICE OF LAW OR CONFLICT OF LAWS RULES OR PROVISIONS. THE INVALIDITY OR UNENFORCEABILITY OF ANY PROVISION OF THESE RULES SHALL NOT AFFECT THE VALIDITY OR ENFORCEABILITY OF ANY OTHER PROVISION, WHICH SHALL BE CONSTRUED IN ACCORDANCE WITH THEIR TERMS AS IF THE INVALID OR ILLEGAL PROVISION WERE NOT CONTAINED HEREIN. EACH PARTICIPANT IN THE RAFFLE IRREVOCABLY AGREES THAT THE WILL COUNTY CIRCUIT COURTS AND THE FEDERAL COURTS FOR THE NORTHERN DISTRICT OF ILLINOIS SHALL HAVE EXCLUSIVE JURISDICTION OVER ANY SUIT OR OTHER PROCEEDING ARISING OUT OF OR BASED UPON THIS AGREEMENT, AND EACH HEREBY WAIVES ANY CLAIM THAT IT IS NOT SUBJECT PERSONALLY TO THE JURISDICTION OF SAID COURTS OR THAT ANY SUCH OR OTHER PROCEEDING IS BROUGHT IN AN INCONVENIENT FORUM OR IMPROPER VENUE. THIS RAFFLE IS VOID WHERE PROHIBITED BY LAW.

The Semi-annual or Annual Raffle Participation Fee is not a tax deductible contribution. The prize winner shall be solely responsible for all federal, state and/or local taxes, including, but not limited to, income and sales tax and all other federal and state and/or local taxes, and all federal and state withholding requirements. The prize is non-assignable and non-transferable. The Raffle is subject to all applicable federal, state and local laws and regulations.

8. Release

Once submitted, entries become the sole property of the Sponsor and will not be returned. Acceptance of a prize constitutes prize winner's permission for the Sponsor to use prize winner's name, photograph, likeness, voice, biographical information, statements and address (city and state) for advertising/marketing purposes worldwide and in all forms of media now known or hereafter developed, in perpetuity, without further compensation. The Sponsor may also disclose personal information in response to legal process, such as a request by law enforcement, a court order or subpoena. By entering this Raffle, participants agree to be bound by these Official Rules and the decisions of the Sponsor, which are final and binding in all respects. Participants agree that the Sponsor shall not be responsible or liable for losses or injuries of any kind resulting from participation in the Raffle, or the acceptance, use or misuse of the prize. Participants acknowledge and agree that the Sponsor reserves the right, in its sole discretion to cancel, terminate or suspend this Raffle should non-authorized human intervention or other causes outside of the Sponsor's control corrupt, undermine or impair the administration, security, fairness or proper play of the Raffle.
